ARMY ROTC



The Reserve Officers' Training Corps (ROTC) is a college elective that develops Leadership Skills in students as they prepare for Military Service. Army ROTC offers a commission as a second lieutenant in either the active Army or Reserve Forces in a variety of career fields including Combat Arms (Aviation, Armor, Artillery, Infantry, or Engineers), Combat Support, and Combat Service Support branches. There are two-, three-, and four-year scholarship programs available. Some cadets choose to join the National Guard or the Army Reserve while in Army ROTC, thus qualifying them for the Montgomery GI Bill benefits, in-state tuition (VANG) and other exciting benefits.

Training with Army ROTC is a new experience every week. Training covers a wide range of skills that are needed to be an Officer in the Army. It includes Situational Training Exercises to teach and practice the different types of offensive operations and tactics used on the battlefield. Rappelling to teach the proper use of knots and to build confidence in cadet's abilities to rappel. Land Navigation to learn the ins and outs of map reading and navigating the land with just a map and a compass. Combat Water Survival Test to test one's abilities in the water during stressful situations. Physical Fitness 3 days a week to make sure cadets are in top shape to pass the Army Physical Fitness Test. Skiing/Snowboard once a year to give the battalion a little extra cohesiveness. There is also a Military Ball and Dining In to bring everyone in the battalion together to have some fun and bond outside of training. armyrotc.syr.edu

AIR FORCE ROTC



Air Force ROTC has a mission "To develop quality leaders for the Air Force." Year after year the program continues to succeed with 145 detachments nationwide who service over 1,000 schools. Scholarships are available for one to four years, paying partial to full tuition, fees, and books. As an Air Force ROTC cadet, students have the ability to earn a degree at Syracuse University or one of our 12 crosstown universities while participating in military training to earn a commission as an officer.

AFROTC is designed to be a four year program. However, it is not impossible for a sophomore or higher to join. They must push their graduation date back or begin graduate school courses in order to satisfy the three year minimum length for ROTC. Prior and current military members, JROTC and Civil Air Patrol members are able to waive the first year of ROTC academics under some circumstances.

ROTC is divided into two sections, the General Military Course (GMC) for freshmen and sophomores, and the Professional Officer Course (POC) for juniors and seniors. GMC cadets attend Leadership Laboratory and AS 100 and AS 200 academic classes to learn about the Air Force and its history, marching, customs/courtesies, uniform wear, and other military skills. There is an option to combine two years as a GMC to take both the GMC classes in one year. Furthermore, there is no commitment as a GMC, unless one is on scholarship. GMC cadets go to Field Training, which is typically in between the sophomore and junior year over the summer. This is where the skills they learned as a GMC are put to the test to determine their entrance into the POC. Most training for the GMC is put together by POC cadets and supervised by the cadre to help the POC hone their leadership skills. The POC have opportunities to further their training, such as Project GO (a language immersion program) or the Army's Air Assault School (Detachment 535 is one of the only Air Force ROTC detachments nationwide to offer this). afrotc.syr.edu

KENT D. SYVERUD CHANCELLOR AND PRESIDENT, SYRACUSE UNIVERSITY

Kent D. Syverud is Chancellor and President of Syracuse University. Appointed by the University's Board of Trustees in September 2013, he assumed the leadership post in January 2014, becoming the 12th leader of the University since its founding in 1870.

Chancellor Syverud came to Syracuse University from Washington University in St. Louis, where he served as Dean and Ethan A. H. Shepley Distinguished University Professor since 2006. Prior to that, he served eight years as Dean at Vanderbilt Law School. During his tenure at Washington University, he led efforts to create university-wide programs in Washington, D.C., in partnership with the Brookings Institution, and in New York in partnership with the Olin School. He also advanced efforts to expand online education opportunities, including development of an innovative online master's degree program.

Chancellor Syverud has served since 2010 as one of two Independent Trustees of the Deepwater Horizon Oil Spill Trust, a \$20 billion fund created by BP in negotiation with the White House to pay claims arising from the BP oil spill in the Gulf of Mexico. A 1981 graduate of the University of Michigan Law School, he also was an expert witness for the University of Michigan in the landmark affirmative-action case *Grutter v. Bollinger*.

After earning a Juris Doctor and a Master of Arts degree in Economics, Chancellor Syverud served as a Law Clerk for Judge Louis Oberdorfer of the U.S. District Court for the District of Columbia and for U.S. Supreme Court Justice Sandra Day O'Connor. He practiced law in the fields of litigation and insurance at Wilmer, Cutler & Pickering in Washington, D.C., from 1985 to 1987. From 1987 to 1997, he served on the faculty of the University of Michigan Law School, earning tenure in 1992 and advancing to Associate Dean for Academic Affairs in 1995. He has been a Visiting Professor at the Cornell Law School, the University of Pennsylvania Law School, and the University of Tokyo Faculty of Law and Politics.

A past Editor of the *Journal of Legal Education*, Chancellor Syverud also has served as President of the American Law Deans' Association, as Chair of the Board of the Law School Admission Council, and as President of the Southeastern Association of American Law Schools. He is a past Chair of the accrediting authority for law schools in the United States, the ABA Section on Legal Education and Admissions to the Bar; and a past Chair of the Board of Access Group, which is evolving into the largest funded nonprofit organization in the world benefitting legal education.

Chancellor Syverud has published numerous law review articles concerning civil litigation, insurance law, and negotiation as well as a monograph on the professional responsibilities of insurance defense lawyers. His more recent writings have concerned legal education and service as Dean, including the articles "*Three Principles of Effective Deaning*," "*A Parable of Law School Leadership*," and "*How Deans (and Presidents) Should Quit*." A frequent speaker at conferences in the United States and abroad, he has received outstanding teaching awards from students at both the University of Michigan and Vanderbilt University.

Chancellor Syverud and his wife, Dr. Ruth Chen, are the parents of three grown sons: Steven, Brian and David. Dr. Chen, an environmental toxicologist, holds a Professor of Practice appointment in the L.C. Smith College of Engineering and Computer Science.

OFFICE OF VETERAN AND MILITARY AFFAIRS

Syracuse University has been engaged in educating military personnel since 1917, when the student body voted in favor of offering military training on campus on February 28, 1917. They then formed the predecessor to today's ROTC units with the first Syracuse University Cadet Corps and marched in the first Chancellor's Review on May 4, 1917. Military education and training has been offered by Syracuse University ever since, including Army and Air Force ROTC, training active duty soldiers and sailors during World War I, running training programs for the Army, Air Force, and Navy during World War II, and offering a variety of military education programs for all branches of the military to the present day with seven different such programs offered across campus.

Syracuse University enjoys a long history of serving veterans, most notably for its unprecedented response to veterans returning from World War II. Chancellor William P. Tolley was committed to realizing the vision of the Servicemen's Readjustment Act of 1944, better known as the GI Bill, which he had helped craft as president of the American Association of Colleges from 1942-1943.

The University's commitment to serving Post-9/11 veterans began in earnest in 2007 with the founding of the Entrepreneurship Bootcamp for Veterans with Disabilities in the Martin J. Whitman School of Management. It was the kernel of what has become the Institute for Veterans and Military Families (IVMF). The IVMF was launched in June 2011 to serve all 25 million U.S. veterans, focusing on the social, economic, education and policy issues affecting them and their families post-service. It offers a portfolio of programs to serve the veterans, transitioning military personnel, and military family members. Through the IVMF's focus on veteran-facing programming, research and policy, employment and employer support, and community engagement, the institute provides in-depth analysis of the challenges facing the veteran community, captures best practices and serves as a forum to facilitate new partnerships and strong relationships between the individuals and organizations committed to making a difference for veterans and military families.

Chancellor Kent Syverud reaffirmed Syracuse University's historic commitment to veterans in his inauguration address on April 11, 2014. He challenged Syracuse University to become "the best place for veterans." In order to lead this charge, he appointed Dr. J. Michael Haynie, Executive Director of the Institute for Veterans and Military Families, to also serve as Vice Chancellor for Veteran and Military Affairs in July 2014. Haynie established the Office of Veteran and Military Affairs in January 2015, thus recreating a new version of Chancellor Tolley's veterans offices to serve the current "Greatest Generation" of American veterans.

The Office of Veteran and Military Affairs (OVMA) serves as Syracuse University's single point of entry for all veteran and military related programs and initiatives. Committed to being the "Best Place for Veterans," OVMA assists university stakeholders to support and empower veteran, military connected, and military family member students and employees who are veterans at Syracuse University.
